### **Harnett Correctional Institution**








The resource materials gathered during the sessions would be very beneficial to the students' planning efforts prior to release as well as their post release.

"Delay, doesn't mean Denial"

When you think of May and June, what normally comes to mind is, warm weather, Mother's Day, Father's Day, and weddings. But a big time of the season is graduation. As most would agree, graduation is just a normal event celebrated most by the actual candidates and those awaiting a loved one crossing the stage. However, the graduation ceremony held for the Shaw University CAPE Program at the North Carolina Correctional Institution for Women (NCCIW) was anything but ordinary.

The celebration began with a dinner for the graduates on Wednesday evening, where Warden Harvey spoke to the graduates about having met a milestone in their educational journey, and her theme was "Turning Negative into a Positive." The festivities continued with a ceremony held in the Chapel at NCCIW on, Thursday, June 7, 2007 at 1:00 pm.

The guest speaker for this unusually enthusiastic and spirited ceremony was none other than Forsyth County District Court Judge, The Honorable Denise Hartsfield. Her theme, "Delay, doesn't mean Denial" was both inspiring and memorable. Her lively presentation captured both graduates and the listening audience as she gave meaning and validity to her point with real life anecdotes from her past. Particularly memorable was her recount of a conversation she'd held with her father about going back and finishing Law school. She recalls for us her hesitation about going back because she would be 35 by the time she'd finish. Her father's response was, "Well, you can be 35 anywhere." So, like the women who were graduating on this day, Ms. Hartsfield, the accomplished judge, did not allow a delay in her plan to stop her from achieving her goal.

Her story continues as she discusses how many of the young people who stand in front of her enter into the correctional system. She adds, 'Now you can let this sentence be an obstacle, or you can make this an opportunity to better yourself'. And as Judge Hartsfield reflects, she said, "I challenged those young people with that statement because of the words my grandmother used to say, 'What the devil meant for Evil, God means for Good'. "I really didn't understand what she meant at the time, but it makes plenty of sense to me now."

Judge Hartsfield concluded with heart-warming words of inspiration and motivation to the graduates, telling them to not let this be their last graduation, and challenged each to inspire someone else to complete their education.

Final comments were made by our commanding official, Warden of NCCIW, Ms. Annie Harvey. She spoke to how fitting the theme and message were and reiterated to the graduates how proud and impressed she was of their accomplishments. She further encouraged the graduates to make learning a life long experience.

By the end of the commencement, fifteen women became alumnae of Shaw University: ten received an Associate of Arts Degrees and five were bestowed with a Bachelor of Arts.
